Carrying out maintenance tasks COVID – 19	Site Staff	<ul style="list-style-type: none"> <li>All tasks which may be carried out by Site Staff must be low risk if working alone.</li> <li>Wash hands on a regular basis with warm soapy water or if non available with an alcoholic hand sanitiser (at least 60%).</li> <li>Wear gloves if possible and when removing take off by removing inside out. Dispose in a bin (with a bin liner inside) wash hands with warm soapy water or if non available with an alcoholic hand sanitiser (at least 60%).</li> <li>Hard surfaces to be cleaned with a mild disinfectant.</li> </ul>	Low	None	
Carrying out maintenance tasks Incidents	Site Staff	<ul style="list-style-type: none"> <li>Site Managers family to be aware of start and estimated finish times and have an emergency phone number of Head Teacher.</li> <li>First Aid available in school.</li> <li>Site Manager to carry a mobile phone at all times.</li> </ul>	Low	None	
Security Incidents	Site Staff	<ul style="list-style-type: none"> <li>Site Manager to ensure they keep the school secure at all times when working on own.</li> </ul>	Low	None	
Statutory Tests and Inspections Maintenance issues	Staff Pupils Others	<ul style="list-style-type: none"> <li>All statutory testing and inspecting to continue as previously prior to COVID 19.</li> <li>In-house inspections should continue to ensure the school remains as safe as possible whilst open.</li> </ul>	Low	None	
Contractors in school Inadequate control measures	Staff Pupils Others	<ul style="list-style-type: none"> <li>Only planned contractors in school are for routine inspections and checks. Where possible, these take place outside the time when most children are in school – as is currently the case.</li> </ul>	Low	None	

		<ul style="list-style-type: none"> <li>• All visitors to school sign wellness declaration and share contact details.</li> <li>• All visitors reminded of social distancing and hygiene measures in place.</li> <li>• Where contractors are coming into school they must have up to date Risk Assessments and Method Statements.</li> <li>• Control measures regarding the Coronavirus must be included within their RAMs.</li> <li>• School to ensure no children or staff are in the area where contractors are working.</li> <li>• Contractors will be designated a toilet they can use whilst on site.</li> <li>• Contractors will be responsible for removing all rubbish they have created and to clean their area of work prior to leaving.</li> <li>• They must ensure no workers are displaying any signs or symptoms of Coronavirus prior to entering the school site.</li> <li>• If they become aware of a contractor coming down with symptoms within 14 days of being at the school they must inform the school immediately.</li> </ul>
